1. Elevating the voice and experience of settlement houses and their communities to drive program development and public policy reform.
2. Shoring-up the NYC settlement house and general nonprofit infrastructure.
3. Sustaining and expanding core settlement house services.
4. Curating and supporting innovative and promising practices.

Along with this reorganization, UNH has expanded the ways in which it carries out its work. Advocacy for and with UNH members now includes regular publication of policy briefs and proactive system change recommendations; member professional development

and peer learning has been deepened with the addition of new peer groups and the enhancement of existing groups; and we have strengthened our role as an incubator and promoter of innovative, promising, and proven models that proactively address settlement house communities' changing needs and opportunities.

All UNH's work targets policies and programs that support settlement houses' infrastructure and the primary populations served throughout the settlement house network: children, youth, families, older adults, and immigrants. Given the range of these populations, and the breadth of the work encompassed by settlement houses, UNH has a broad range of topics on which it can focus each year. The issues, programs, and capacity building initiatives on which UNH selects to delve deeply each year are determined by UNH's clear understanding of the political and programmatic "landscape", and driven by its members through: direct polling of settlement house leadership; the annual settlement house Executive Director's retreat and monthly Executive Director Council meetings; the member survey and member review process; and information gathered from year-round peer group meetings and settlement house site visits. Priorities are also informed by UNH's areas of expertise and influence, and recognition of where related organizations are, and are not, meeting the need.

#### Elevating the Voice & Experience of Settlement Houses

Over many years, UNH has established a deep level of advocacy and policy experience, with demonstrated success in advocating on behalf of settlement houses and New York City nonprofits more generally. UNH is looked to by the settlement house network as the means for ensuring their voices are heard during the City and State policy and budget decision-making process. The City and State also look to UNH for the on-the-ground perspective, to better understand the experience and expectations of

nonprofits and the communities they serve. This experience and access to both sides of the policy "table" provides UNH with the distinct ability to read and respond to the political landscape at any given time.

Examples of UNH elevating the voice of settlement houses this past year include:

Restoration of 26,000 summer camp slots in the City budget by working with 400 summer programs across the City to analyze the impact these cuts would have on working families, and organizing "Summer Camp at City Hall" where more than 300 young people came to City Hall to showcase their summer learning.

Organizing older adults and service providers to meet with members of the State legislature, the New York State Office for the Aging, and the Division of Budget to advocate for the preservation of critical services provided by the Naturally Occurring Retirement Community (NORC) program. This resulted in the State Enacted Budget rolling back the Governor's proposal to close NORCs that did not meet density and demographic requirements set by outdated laws, established statutory changes to the NORC program to keep programs in compliance and encourage future growth, and included an additional \$700,000 for the program.

Training 19 frontline settlement house staff to be advocates for their organizations and communities through the Strengthening Advocacy Skills program, conducted in partnership with the Advocacy Institute (AI). This training provides front-line settlement house staff with the tools and information to support successful advocacy for social justice and movement-building campaigns, and establishes organizing points-of-contact within the settlement houses to facilitate UNH's advocacy efforts.

#### Shoring-Up NYC Settlement House and General Nonprofit Infrastructure

UNH works with its members to meet the challenges of providing services to their communities in an environment where competition for resources is fierce and the demand for programs is great. This work takes place through advocacy, and opportunities for staff at all levels to build skills, knowledge, and capacity; showcase and share expertise and best practices; and spark thinking, action, collaboration, and innovation.

Activities to shore-up settlement house infrastructure in 2016 and the first quarter of 2017 included:

- Expanding and deepening peer learning activities. This included the addition and revitalization of peer groups of staff who support organization infrastructure. For example, a peer group of Facilities staff was launched this year, and an enhanced schedule of Human Resources and CFO peer group meetings was implemented. These groups were added or rejuvenated at the direct request of settlement house Executive Directors. Like UNH's advocacy agenda, topics addressed in peer learning meetings and events are determined by settlement house staff to ensure relevancy, engagement, and impact. Topics are a mix of trainings and peer discussion.
- Securing the first collectively bargained wage increase in 10 years for staff, teachers, and directors of City-contracted early childhood education and child care programs. UNH members identified early childhood salary parity as a top priority for the management of their programs during the City's expansion of Pre-Kindergarten programs. In support of this priority, UNH played a leadership role in both the public campaign and the closed-door salary negotiations in support of salary parity for early childhood education workforce. This included the production of a policy

brief, *Losing the Best*, which describes the salary disparity issue and its impact on retaining quality staff in community-based early childhood education program.

#### Sustaining and Expanding Core Settlement House Services

A key role of UNH is to support settlement houses' continuing capacity to offer core services that support the communities they serve, as well as to expand their work to effectively meet changing needs in their communities.

Examples of UNH's work over this past year to sustain and expand core settlement house services include:

- Training Early Childhood educators and administrators to recognize and address child and family trauma.
- Securing the first funding increase for Beacon Community Centers in 25 years.
- Historic funding expansions for adult literacy programs.
- Training 22 staff from 16 settlement houses to be the next generation of settlement house leaders through UNH's Emerging Leaders Program, delivered in partnership with Baruch College's Office of Executive Programs at the School of Public and International Affairs. The cohort currently enrolled in the program includes 25 staff from 22 settlement houses and UNH.

#### Curating and Promoting Innovative and Promising Practices

Examples of this work, which is ongoing, includes:

- Promoting settlement houses' continued pioneering of Family Literacy methods, with UNH bringing practitioners experts, and parents together to uncover, improve, and promote an emerging field of practice. This work includes efforts to secure new resources to support family literacy programming, promote flexibility in current funding streams

to facilitate implementation of a family literacy model, and, with a workgroup of settlement house, continue identifying barriers to family literacy models utilizing current public funding streams.

- Providing thought leadership in an emerging practice that empowers older adults to become change-makers within their neighborhoods. A growing body of research shows that when older adults are mobilized in meaningful activities they help improve their communities and markedly improve their own health and wellbeing. UNH worked with the staff and participants of five senior centers in 2016 to build the capacity of older adult services programs to change how they do their work. UNH presented the results of an external evaluation of this project and the lessons learned from implementing the project at the 2016 National Grantmakers in Aging conference.

- Engaging residents of NYCHA housing to promote access to, and use of, healthy food in their neighborhoods. UNH is working with three settlement houses to increase the accessibility and affordability to healthy food in diverse, local projects that are being led by and for NYCHA residents.
